- III. <u>REVIEW NEW COOPERATOR AGREEMENTS & CONSERVATION PLANS:</u> Three representatives from Hartung Bros. were present to present the plan. Hartung Bros. took over Syngenta's operations two years ago. Their conservation plan is for their Waimea fields. Adam motioned to approve the plan/Blaise seconded; the motion was unanimously accepted. The Conservation Plan was signed by Peter.

IX. UNFINISHED BUSINESS:

- A. Slow Money Hawaii (SMH): Rebekah opened up the discussion about any feedback from the Skype session with Mary. There was no verbal feedback at the time of the meeting. Rebekah explained how Eric Hansen from the EK SWCD is looking into Slow Money Hawaii for a project he is doing with kava. He is going to learn about the process and give feedback on what he learns so he can better explain to other borrowers and the Districts. With Eric going through the process the Districts can better learn how they fit into the program and how they can support it. Umi brought up the fact that SMH would have to build up their network of lenders on Kauai. Rebekah also explained that Oahu lenders can lend to Kauai borrowers but the ideal plan is to create a network of lenders on Kauai that support Kauai borrowers. Kiva is the first step for the microloans with 0% interest through SMH. Peter asked if there was any interest in the WK District but Rebekah was unaware of anyone at the time of the meeting.
- **B.** Piggerys on Kauai: After his Conservation report, John talked about how there has not been much headway made with the Dept. of Ag on learning about why the landowner concurrence letter was not signed for a particular piggery. He said it is a project by project evaluation and they did not know the benefits of deep or dry litter systems for the piggery. He explained that there needs to be a 50 feet set back from drinking water and canals but none for residences and schools. There are very loose regulations and no permitting for the piggeries. Bailey mentioned how the DOE now has contracts for serving locally sourced beef at schools. John also said that the DOA is coming out in the middle of June to meet with the piggery client.

X. OTHER BUSINESS:

- A. WK SWCD Chair: Peter has been talking to the vice-chair, Howard Greene, to see if he will be the acting chair. Blaise made a motion to make Howard Greene the acting chair until a more permanent status is determine by the board, David seconded. The vote was unanimously accepted. Peter also suggested that chairs could be switched up or changed each year.
- **B.** Ted Kornecki, USDA: Rebekah has been in contact with Ted Kornecki who is in Auburn, AL. She will send out an email with more information on Ted with his accomplishments and Youtube videos for examples of his prototypes. The Districts hope to bring Ted to Kauai to give a workshop on small machinery appropriate for small/beginner farmers with limited resources.
